1. The STAGE-s are open to all who have at least two years of study in any field of Dance and will be limited. The STAGE-s will be effective after reaching a number decided by the organization.
2. The dance lessons for students are 60 and 90 minutes per day for a total of 7 days.
3. The entry fee is set at 30 € and includes the registration fee as members ASCD Dance Giselle, secretarial, insurance only applies to trainees during the course of dance lessons and a certificate of attendance, the same amount is not subject to any kind of discount and is not refundable under any circumstances.
4. In the case of minors the entry must be signed by parents or his guardian.
5. Teachers have the right to change the course participants attending courses as they deem unsuitable for their preparation.
6. The Pass for access to the lessons to be collected a day earlier, at the Secretariat of the stage, after complete presentation of the receipt of payment of the full cost of the courses or packages selected for participation in any refundable except cases of serious illness, death or injury serious. All tender documents must be accompanied by two passport photos for each participant, the tax code and a certificate of good strong constitution.
